Summer is coming fast and that means it's time for our annual city-wide event "Isanti Rodeo Jubilee Days." Once again, Heritage Corral will be part of the Jubilee Parade and Kids Fun Day. Heritage Corral consists of vendors of all kinds.

The cost per booth for the parade is \$80.00. The cost per booth for Kids Fun Day is \$55 for businesses and organizations (\$30 for non-profits.) If you commit to both the parade and kids day, the cost per booth is \$130.00. These fees include the city-required peddlers permit. North 65 Chamber members will receive a 10% discount.

SET UP: PARADE – THURSDAY, JULY 5, 2018

Food vendors ONLY. Set up for the parade is 3:00 – 5:00 pm. You may begin serving upon set up. The parade officially begins at 6:30 pm, however spectators begin lining the street around 4:30 pm. Parade ends at approximately 9:00 – 10pm.

SET UP: KIDS FUN DAY SATURDAY, JULY 7, 2018

Set up for Kids Fun Day is 7:30 am – 9 am. Kids Fun Day begins at 9 am and ends at 3 pm. Vendors will set up in the Isanti City Hall/Isanti Community Center parking lot off of 1st Ave (north of Main St).

Neither electricity nor tables are provided, so please plan accordingly for items you may need. Generators and pop-up tents are allowed.

Booths are available on a first come, first serve basis. Priority will be given to return vendors. This is a rain or shine event. No refunds will be provided. If you are interested in becoming part of Heritage Corral, please complete and return all of the following as soon as possible, but no later than **June 15**:

3. Copy of insurance declaration page
4. If a food vendor – copy of your State Health Permit
5. Payment in full – checks made out to North 65 Chamber of Commerce
